The agency distributes food, baby food, baby supplies and other items to low-income residents of West Seattle. In fiscal year ending June 30th, 2011 families visited the agency 38,838 times and the agency distributed 1,057,652 pounds of food. The agency also delivers food to homebound elderly and disabled residents in the area, distributes food through the local senior center, and provides vouchers for clients to purchase fresh produce at local farm markets.
